As always, the Credit Union strongly encourages members to regularly review statements for accuracy. Check Equifax's website at www.equifaxsecurity2017.com to find out if you've been impacted and enroll in free credit monitoring. The enrollment period ends November 21, 2017.

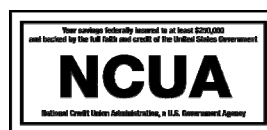
